Illahee Store - 1/11/17 Report

- 1. Testing results (12/19/16) showed low levels of contamination in two places, which suggests a fairly straight forward cleanup with the removal of the tanks. Ecology was notified and our site number is ERTS 669620.
- 2. Site is contained underneath by hardpan at ~11 feet and laterally by structural and utility (roadway) impediments, i.e. Illahee Road and All View Blvd.
- 3. Tank removal estimates: #1 \$27,352 plus tax; #2 (pending).
- 4. Ecology meeting on 1/5/17 with the NW Regional Director for Toxic Cleanup indicated they want to work cooperatively with us to clean up the site and may even have funding to help.
- 5. There are several procedures available for cleanup:
 - The 2013 "Model Toxics Control Act" manual requires a remedial investigation, feasibility study, and disproportionate cost analysis, along with Ecology fees.
 - The 2015 "Model Remedies" publication was developed for sites like ours and is simplified and less costly. It appears either Model Remedy 1 or Model Remedy 3 would apply to our site.
- 6. A PLIA (Pollution Liability Insurance Agency) application was submitted after the testing results came in. Application deadline date is March 1, 2017 and abandoned sites like ours qualify. The financial release form needs to be completed upon acquisition/pre-acquisition.
- 7. This provides two possible sources (Ecology and/or PLIA) to recoup any cleanup costs, should the Port purchase the property.
- 8. If the Port can acquire a needed commercial piece of property and building at a reasonable price that takes into account the costs needed to bring it into code compliance to function as commercially leased property, a community center, and a Port office, then it should proceed with the acquisition.
