

All work will be done by means of state-of-the-art technology in the asbestos industry, utilizing the latest developments in training, equipment, products, and methods. Work practices are as per guidelines established by the U.S. EPA, NIOSH, NESHAP, OSHA and WISHA. Abatement will be performed by experienced, trained and certified technicians/supervisors. K C B is licensed, bonded and insured as a General Contractor and as a Certified Asbestos Contractor in the State of Washington. Transportation of generated asbestos waste as per DOT regulations, and disposal at an EPA-approved Hazardous Substance Landfill, all paperwork is available at request. Currently the waste is shipped by rail to Arlington, Oregon. Notifications made to Department of Labor & Industries Asbestos Division, the local air pollution control authority, and! or Environmental Protection Agency, as required. Air sampling, when necessary is included; the results will be made available to the owners when received by the EPA-approved (NVLAP/PAT) lab. A coating of penetrating encapsulant will be applied to all areas where asbestos is removed. No re-installations are included. Other trades will not be able to work in the premises during the abatement activities.

We propose to remediate *asbestos-containing materials* (ACM) in the following locations; Exterior CAB (cement asbestos board) installed at the crawl space entrances (and some unused pieces); flooring; first layer installed in the middle level in a bathroom (orange sheet vinyl)

We will provide the Puget Sound Clean Air Agency to remove the asbestos. Owner should remove all items from the bathroom (except shower/tub fixture). Destructive methods will be employed to access the asbestos flooring (with non asbestos on top). We will transport the generated asbestos waste to a certified shipper of an approved transfer station. All work will be done in strict compliance to regulations pertaining to asbestos in local, state and federal regulations including 40 CFR 763; WAC 296-62-077,40 CFR 61 (NESHAP); PSCAA. Water and power must be provided by owner, or costs associated with obtaining utilities may be added to this price.

Contract amount: \$ 708.00 plus sales tax at the local rate.

Payment is due immediately upon completion of on-site work and receipt of invoice.

This price represents the conditions noted on 1.6.16; any deviations which might affect the work practices could result in additional costs. Please contact our office immediately if any changes occur. Project specifications: A Completion Certificate will be forwarded to you immediately following the on-site portion of the project. Please allow day to complete this remediation, in consideration of illness, equipment failure and unforeseen circumstances.

On all jobs we are required by law to furnish to owners of all real property, where we have delivered materials and! or supplied labor, notice that in the event of non-payment of this account, a lien on the property may be claimed by us. The owner expressly agrees that should it become necessary for KCB to place this contract in the hands of an attorney for collection, or if suit shall be brought to collect any of the principal or interest due under this contract, the owner shall pay, in addition to the principal and interest due, a reasonable attorney fee, and further, the owner shall pay all costs of the legal action, including but not limited to, filing fees, payments for witnesses, and court costs. The owner agrees that in the event it becomes necessary to enforce any of the terms and conditions of this contract, that the form, venue andjurisdiction in that particular action shall be Kitsap County, Washington.
KCB is registered with the State of Washington, #KCB****922J5 as a general contractor and has posted with the state a bond of \$12,000.00 for the purpose of satisfying claims against the contractor for negligent or improper work or breach of contract in the conduct of the contractors business. This bond may not be sufficient to cover a claim which might arise from the work done under your contract.
