# Port of Illahee Grant Report 12-8-10

- 1. Local forester and arborist, Jim Trainer, has submitted an Illahee Creek riparian planting plan proposal, which focuses on the lower reaches of the creek. We have submitted a draft landowner agreement document to DOE for their review and approval, and are waiting for their response. Once the landowner agreement is complete, the contract of the planting is expected to be approved.
- 2. The rain garden is looking good after the mulching, weeding, and washed rock simulated stream bed was put in. During the last work party we completed lining the rain garden with logs. The logs and the rock are hoped to prevent vehicles from driving through and destroying the rain garden.
- 3. Public Information and Education task work continues.
  - Our filmmaker hired to present the findings of the Parametrix report and more has been filming various events such as the last Rotary work party and the scout sign installation work party.
  - Vic Kerenen is working on a draft of the first layer of signage for the Illahee Preserve that will be used in conjunction with the rain garden signs. The first layer will include the logos of all the various organizations working in the Preserve, including the Port of Illahee. We have been using the logo on the Port's letterhead unless there is another logo.
- 4. Joy Davison began the entry of the prepared documents for the West Sound Watershed Council (WSWC) into the Habitat Work Schedule (HWS) used by the Puget Sound Nearshore Ecosystem Restoration Project (PSNERP) & Puget Sound Partnership (PSP) databases, to document current and future restoration projects and should have completed the entry of 16 projects.
- 5. We are trying to set up a meeting with Josh Brown and Jim Dunwiddie to present to them the projects in the Habitat Work Schedule as nearly each one of them affects the Illahee Preserve and both directly and indirectly the results of the DOE/Port funded Parametrix report.
