Hello Commissioners,

I manage DNRs Ports Program and all agreements with Port Districts.

It looks like the DNR-Port agreement for the POI dock expired in2015. We will need to pursue a new agreement. For a public access facility DNR would issue a no-fee lease. If there are any commercial uses of the facility please let me know.

There should not be any issue other than the need for an updated survey. As far as my records show the exhibit attached to the agreement above is not consistent with the boundary described. It looks like the structure extends below Mean Lower Low Water and is on State land. If the area ever goes dry let me know and we can look at the ownership. The old drawing shows the waterward end of the dock extending below MLLW. I belive that is correct. I can give the Port one or perhaps two years to provide the survey.

With your permission I will fill out an application and get the process rolling.

If you would like I can provide a draft for review by the Port attorney. I will need a couple of weeks.
