Port of Illahee Minutes of Regular Meeting July 8, 2020

Due to the COVID-19 Virus and Governor Inslee's Proclamation 20-05 the meeting was being held virtually through the ZOOM app (meeting id# 71509975823). Notice of the virtual meeting was posted near the kiosk at the head of the pier and on the Port's website – portofillahee.com.

CALL TO ORDER

Commission Chairman James Aho called the meeting to order at 6:30PM. Also in attendance were Commissioner Jonathan Buesch;
Commissioner John Burton; Administrator, Theresa Haaland; Roy Barton; and Ed Seal.

CONSENT AGENDA

Commissioner Buesch moved to approve the consent agenda items: July Meeting Agenda; June 10, 2020 Regular Meeting minutes; July 8, 2020 checks numbering 4628 through 4638 totaling \$8,315.73 as outlined in the attached Voucher Approval; second by Commissioner Burton; approved unanimously.

SIGNING OF DOCUMENTS

Commissioners agreed to individually stop by the Port of Silverdale office tomorrow, July 9, 2020 sometime between 11:00AM and 3:00PM to sign the necessary documents.

Treasurer's Report

As of June 30, 2020 the General Fund totaled \$16,447.76, Investments totaled \$375,339.95 and

the balance of the Good Property Management account totaled \$200.00.

Commissioners' Reports

Website - Commissioner Aho reported that he has not yet added the links to the Illahee Creek Watershed Report/Surface Water Management Plan or the County's mussel sampling results. He did add a link to the Recreation Conservation Office's (RCO) online PRISM system that is open to the public to review grant information. The public is able to view the Port's two grant applications and the Power Point presentations that Soundwest Engineering provided to the RCO on June 29th.

Rental Properties

5560 Ocean View Boulevard/Rental Property — Commissioner Buesch reported that there is still not a signed lease in place. The tenants continue to pay the required rental amount each month. In talking with Good Property Management personnel, Commissioner Buesch was told that not having a signed lease in place isn't necessarily an issue.

5500 Illahee Road/Rental Property — Commissioner Buesch hasn't recently heard from the tenants, so believes everything is okay. Commissioner Burton reported that on the 5th of July he noticed the big cedar rounds that are on the edge of the property were smoldering. Commissioner Burton along with Dave who resides at the house, were able to take care of it. Commissioner Burton talked to the tenants and asked them about their use of fireworks on the 4th. He was told that they took all the precautions necessary by having a hose readily available, which Commissioner Burton did see on site. He said it looked as though someone had intentionally tried to set the rounds on fire. There





was evidence of small unlit fireworks as well as firework debris all in that area. The concrete wall is still stable, but it is now somewhat unsupported. Commissioner Buesch said that he would go take a look at it.

5507 Illahee Road/Illahee Store Property - The redemption period will be complete on September 6, 2020. Then the Pollution Liability Insurance Agency (PLIA) will be notified that the Port is the official owner of the property and remediation of the contamination can be planned. Commissioner Burton said that he has a routine of picking up trash around the store area. Within the past couple of weeks he has noticed more and more vaping and cbd oil packaging on the ground. Recently, he picked up a used hypodermic needle. The other day it was noticed that a couple of young ladies had parked a vehicle in the store lot and were seen walking behind the store. Commissioner Burton went to the area and confronted them. They were back there smoking and informed Commissioner Burton that they just wanted to take a picture of the graffiti that is on the south side of the property. He informed the young ladies that the area is not opened to the public, at which they seemed surprised but did leave without incident. Commissioner Burton is concerned that the area behind the store is going to be used more and more for illicit-type activity. He suggested it be fenced. Commissioner Buesch said that possibly placing a five-foot chain link fence might deter people from going back there. It might be worth getting an estimate and have it include a gate with a padlock so that it can still be accessed if/when needed. Commissioner Burton reminded everyone that the owners of the triangle piece of property

asked the Commissioners to build a fence to keep individuals from entering their property.

Splitting the costs of a fence with the adjacent property owners may be a possibility, although that is a different area than what was currently being discussed. Commissioner Aho said that there are still two months before the property is officially owned by the Port. He suggested to hold off on it. Also, in regards to individuals accessing the adjacent property, it may be incentive for the property owners to sell that triangle piece of property. Commissioner Buesch suggested that the orange plastic fencing be installed as a temporary fix. Everyone agreed and Commissioner Aho has some he will donate.

Commissioner Buesch asked if the others would be in favor of him researching if it would be possible and if so, what it would take to split the 5560 Oceanview Boulevard property and the septic reserve lot, so that the two could be sold separately in the future. This has been discussed in the past and it has been set aside until the Port may need cash. With the grants moving forward and the matching funds that may be necessary, now may be the time to at least have an idea if selling the two parcels separately is a possibility and if so, what it would take to do that. It was agreed that it was a good idea. Commissioner Buesch will research it.

<u>Dock/Pier</u> - Commissioner Burton said that he was hoping Lee of TIKAR Services would be attending tonight's meeting, but he noticed TIKAR had just left the dock about twenty minutes ago. TIKAR made some good progress on the float that is closest to the land. They removed the dock boards and the rot was so significant it ended up taking





them less time to remove all of it. Commissioner Burton reported that he ordered two cases of Mutt Mitts and the station is now stocked.

Lee Knapp of TIKAR Services entered the meeting at 6:55PM

Commissioner Burton said that he believes that due to the COVID virus families are spending more time outdoors. He has noticed that the entire dock is getting a lot of use, especially with swimmers and fishermen. He said that the sooner the repairs are completed the better. Lee explained that he was attempting to get photos of the repair to upload onto ZOOM so that he could show everyone the progress. He said that repair to the south float began yesterday. TIKAR is about two-thirds of the way done with the repair to that float. He explained that the esthetic deterioration was expected, but they were surprised to find some structural components weren't fully connected and the tie rail snapped sometime in the past. The new tie rail bridges the gap of the beams that were originally used to construct the float, leading to a much sturdier structure. The entire reconstruction is aimed at creating a much stronger structure. Commissioner Burton requested a seventh cleat be installed on one side of each of the floats. He explained that the cleats are strategically placed and there will be plenty of tie-up space for boats. Lee added that the cleats are bolted all the way through with heavy duty bolts. They will be very strong and able to handle just about anything. Lee explained that some deck boards are in need of replacement on the south float. An entire area on the north float looks as though the deck boards need to be replaced, but TIKAR won't know fully how many until it is deconstructed. Commissioner

Burton asked TIKAR to be aware of the limitation of new deck boards to stay in accordance with the permit. Lee assured they are aware of the limitations and will not exceed what is allowed. He explained that they plan to complete the full deconstruct and reconstruct of the north dock on Friday. They do not want to leave it unfinished overnight for safety reasons. Commissioner Burton said that he was down on the dock with Lee and Tim overseeing the project. The northwest piing on the south float is hollow. A section of it has rubbed off and you can see it is hollow. He said that we already knew some were not fastened under the water, but they are even worse than originally thought. He said sleeving the pilings need to be considered. Lee explained that the inwater work window is between August 1st and 31st. The process of sleeving pilings was discussed. Lee said that it is basically turning a wood piling into a concrete piling. Commissioner Buesch said that since the only part of the piling that is able to be sleeved is the part that is continually in the water. How do we know that the part of the piling that is below the sea ground isn't rotten? Lee assured that the sleeve will go down about six inches into the ground and past that point the pilings typically look new with all the rot occurring above that six inches. Commissioner Burton suggested John Piccone be asked to take a look at this since an engineering report would be necessary. Commissioner Aho said that yes John Piccone should look into it not only from an engineering standpoint but also because he is working on the grants. It must be determined how much money the Port would be willing to spend for repair verses replacement. Commissioner Burton said that he is concerned that the piling won't last until if/when the grant money is awarded. He does not see them lasting

two more years. Commissioner Aho will direct John Piccone to contact Lee. Placing a bar or a cap that spans along the pilings, tying them together was discussed. Lee explained that tying a weaker piling to a stronger one helps stabilize the weaker one, but that would be more efficient after sleeving. It must also be determined beforehand that there would be adequate headroom. Commissioner Buesch asked if the piling repair could be a retroactively reimbursable cost if/when the grant is awarded. Commissioner Aho informed him that no, because the grant money is for new piling. Commissioner Buesch said that he agreed something needs to be done, but it would be a shame to spend all this money on items that are going to be done away with for the grant project. Commissioner Burton thought maybe the sleeved pilings could be removed and reused. Lee explained that would not be possible as they would be required to be steel. Commissioner Buesch said that it almost seems like a waste of money, although he knows they are needed, but it's just for such a short amount of time. If the pilings are to the point that we have to spend a lot of money on them for just one year, maybe we can just get through this summer and then close them off. Commissioner Burton said that we are providing a service to our patrons that are using it right now, the state of disrepair is due to the years of postponed maintenance, now it's time to catch-up and make the facility safe. Lee explained that he doesn't think it would be possible to complete a piling sleeve project this August anyway. The material alone can take months to receive. The timeline would be for August 2021. Commissioner Burton said that working in parallel with John Piccone to complete the engineering aspect of this so that the Port is ready even if the grants are not

awarded. Commissioner Aho said that the permit applications for the grant project will be submitted soon and when and if the grant is awarded to the Port, the project will be ready to go. Lee was dropped from the meeting.

Commissioner Aho said that he emptied the container that holds all the monofilament (fishing) line that fishermen would throw out. The container was installed by the Department of Fish and Wildlife (DFW) in 2017 in an effort to keep the monofilament line waste out of the waters. Commissioner Aho said that he thought this was the first time the container had been emptied and he was amazed at the amount of nylon fishing line that had been deposited over the past three years. He was thankful for the design of the container, which allowed him to empty it from the bottom. He sent DFW an e-mail so they were aware that it is a successful program.

Lee was able to reconnect to the meeting at 7:25PM.

Lee provided pictures via his laptop showing the before and after the repair of the inside float. He explained that with the polyethylene material it will be much easier to maintain and cleaning will be easier as pressure washing will not damage this material.

Grants – Commissioner Aho recapped the
Recreation Conservation Office (RCO) grant review
presentations via ZOOM. Lauren Swanson of
Soundwest Engineering was the presenter and
Commissioner Aho said that she did a good job.
Commissioner Aho talked with Chris May of Kitsap
County Public Works, Stormwater Division





regarding incorporating the County's stormwater plans with the Port's grant plans. At this point the County is trying to figure out a way to fund that commitment as they have a budget shortfall.

<u>Illahee Day 2020</u> – Commissioner Aho said that this will continue on the agenda as a placeholder for further discussion after September 6, 2020 when the Port is the official owner of the property.

NEW BUSINESS

Illahee Preserve — a letter dated July 7, 2020 from the Illahee Preserve had been received. It explained that the Preserve and the County are working together to acquire additional property for the Illahee Preserve by applying for a 2020 RCO Urban Wildlife Habitat Grant and they were hoping for a letter of support from the Port.

Commissioner Aho explained that the Preserve has requested letters from other elected officials, the tribe, the Rotary, etc. This is something that is

looked favorably upon by the RCO, showing community support of the project. He said that as for the Port's grants the survey that was conducted serves as the community's support, so support letters will not be necessary. Commissioner Burton questioned what jurisdiction the Port has to send a support letter and if this would create a liability to the Port. Commissioner Aho explained that since the Illahee Preserve is within the boundaries of the Illahee Port District, the Port has a voice about it. He explained that the Mayor of Bremerton and Representative Sherry Appleton will also be asked to write support letters. Commissioner Buesch said that he is in favor of supporting the Illahee Preserve. Commissioner Burton said that he didn't see the Port having much of a voice over nonmarine habitat and feels it is kind of out of the

Port's purview. Commissioner Aho assured that submitting a support letter will bring no liability onto the Port. The Port's mission is to support economic development and recreation and he sees supporting the Illahee Preserve as supporting economic development in the affect that the Preserve supports recreation. Commissioner Buesch said that Illahee Creek flows into the Port's waterfront so if the Preserve can acquire more property to help with keeping the water that eventually flows into the Puget Sound purer, he is in favor of it. Commissioner Aho reminded everyone that the Port has been concerned with the stormwater runoff from upland development for many years. You can watch former Port Commissioner Dennis Sheeran talk about it in the film: "Illahee, Saving Puget Sound One Watershed at a Time." Commissioner Burton agreed that the Port supporting the watershed and protecting watershed properties to do that does makes sense. He asked what properties this grant is going to be used to acquire. This was discussed.

Commissioner Aho moved to submit a letter from the Port of Illahee in support of Kitsap County and the Illahee Preserve to acquire additional property to expand the Illahee Preserve; second by Buesch; approved unanimously.

PUBLIC COMMENT – Roy Barton asked about the conceptual design of the Illahee Store.

Commissioner Buesch said that Pro Design is working in conjunction with Soundwest Engineering.

Commissioner Burton asked if the Washington Public Ports Association (WPPA) will be hosting the Small Ports Seminar in Leavenworth this October. This will be looked into.

Hi everyone,

Just want you all to be aware that Jim received a call from Russell Olsen, the Executive Directory of PLIA, on July 28th and confirmed that the Port is still in the cleanup queue.

The organization has been feeling the impact of furloughs, etc and are working with limited staff and some funding issues. They have been going down the list that was established some years ago and are at #8 or #9. The Port continues to hold steady at #16. Some of the projects will cost \$1M plus and since Illahee is a relatively smaller project at \$540K, it may be able to be squeezed in somewhere.

Russ was glad to hear that the Port will be ready soon and even mentioned the slight possibility of September or October if funds become available that will help get people back to work. More will be known soon.

Jim mentioned the plans for the building and that it now has a new roof and a cleaned interior, and that when the tanks come out the Port is looking at using the excavated hole for installing a sewage holding tank, since there are no sewers or room for a drainfield on the property.

Russ also mentioned that the Port's point-of-contact for the project will be Carrie Pederson, and at some point they may want to come out and look at the site.

Plywood has been ordered, I will let you know when it arrives to our shop.

I have not scraped the ladders yet because I wanted to get the paint and clean price to you first.

For me the scrape them in the water will be about \$70

For me to pull them out, scrape, clean, then blast them. Then coat with an aluminum safe anti biofouling paint (VERY expensive paint) and re install. For all that work your looking at around \$375.

We did our best to get this price down but the paint is extremely pricey and there is a lot of prep to get them ready for coating.

Let me know what you want me to do.





Shelly -

Lots of great things are happening and planned in Illahee and I think it is time to consider a follow-up film, a sequel, to "Illahee, Saving Puget Sound One Watershed at a Time".

Just to give you an example of some of them:

- 1, Yesterday I talked with the Executive Director of PLIA (Pollution and Liability Insurance Agency) about cleaning up the underground storage tank contamination at the old Illahee Food Store. We are #16 on the State list for cleanup and could be looking at that happening some time in the near future. We will complete the one year redemption period required after a Sheriff's Sale on Sept 6th which will give us final ownership of the property.
- 2. The Port is applying for several grants to upgrade the dock and upland area, and are looking at working with the county to provide some type of vault system to clean up the stormwater that exits at the dock. This item is not on their master plan, but they want to do it, so we are thinking the film prospect may help move it forward.
- 3. We did finally purchase all the Timbers Edge properties for \$1.435M with the support of our County Commissioners, several grants and the community and now are working on a grant to use some of that as the required 50% match to go after more property. The TE property owner and the developer are interesting people who would be good people to interview.
- 4. The first priority of the grant we are working on is to acquire a 29 acre parcel that has the South Fork of Illahee Creek running through it. I walked it yesterday and it has a pond complete with beaver activity, something we hadn't anticipated being present in the Illahee Creek watershed, but beavers were suggested as beneficial in one of the Ecology reports.
- 5. The property is quite unique and owned by a 97 year old gentleman who is out there working like he is in his 50's or 60's. He has lots of stories including being in Africa during WWII if I understood him correctly. Definitely a person who should be interviewed before he departs us.
- 6. His property would be the envy of any and all developers, but he doesn't want it to be developed, which is why we are trying to work with him. The property has an interesting history as a homestead and farm, complete with an old historic house, with old growth trees along the ridge.
- 7. We are trying to amass nearly \$1M in matching funds to buy that property and also several others that are being threatened with development, including a headwaters stream for Steele Creek, and two wildlife corridors

that connect the Preserve with Illahee State Park. We had two properties gifted to the Preserve by Kitsap Bank and we now need to finish up the purchase of two other properties as they were going through permitting.

8. And since the first film the local Rotary Club added a shelter at our primary entrance, and continue to support the Preserve, so there are some attractions along with interesting people to interview.

I hope I have enticed you a little with what is going on, but before I start looking for interest and more importantly funding, are you interested and available to do a follow up film?
