CALL TO ORDER

August 9, 2023

Commission Chairman James Aho called the meeting to order at 6;30 PM. Also, in attendance were Commissioner Jonathan Buesch; Commissioner Jeffrey Rupert; Administrator Jennifer Olson; Roy Barton; John Parvis and Janet Soderberg

CONSENT AGENDA

The following consent agenda items were approved: August Meeting Agenda; July 12, 2023 Meeting Minutes; checks numbering 5063 through 5076 totaling \$25,746.25 as outlined in the attached Voucher Approval (motion by Buesch; second by Rupert all in favor).

SIGNING OF DOCUENTS

Commissioners plan to stop by the Port of Silverdale office to sign documents tomorrow.

PUBLIC COMMENT

A local community member asked, why are there barrels at the Illahee store?

Commissioner Aho responded that a contractor contracted thru PLIA needed to drill two more wells.

REPORTS/UNFINISHED BUSINESS - Commissioner Aho said that they are behind on approval for permits and still waiting on them.

Commissioner Aho reported that there is a meeting with the Suquamish tribe on August 31, 2023. Commissioner Buesch asked who was going to be at the meeting? Commissioner Aho replied, the Port's attorney, Commissioner Aho, John Piccone, the engineer on the waterfront improvement project and the attorneys for the tribe.

The Suquamish tribe is concerned about what will happen, when the Port replaces their fishing dock and pier, how will this affect the Geoduck harvesting? Commissioner Aho discussed he is going to bring reports that show that the Port replacing their dock and pier will have no to very little effect on Geoduck harvesting.



Commissioner Aho will have a discussion with John Piccone about the possibility of issuing bid requests during the winter season if the meeting with the tribe proves to be successful. Commissioner Buesch asked Commissioner Aho if he could contact the Port Administrator to give a summary of what transpired at the meeting with the tribe The Administrator will then update the other members of the Commission.

SLR the construction company that is contracted thru PLIA (The Pollution Liability Insurance Agency) just finished the drilling on two new wells at the Illahee store sight.

The DNR (Department of Natural Resources) visited the Port of Illahee on Tuesday, July 18, 2023 they are looking into renewing the aquatic lease agreement with the Port. Cailan from the (DNR) came to the Port and walked the Property with Commissioner Aho. At one point she looked up at the lights on the dock and asked if they were going to stay? There was much discussion amongst the Commissioners about the squid fishermen being upset if they did not have lights. Historically the Port has hosted squid fisherman for a long time, no lights would be a big deal. Commissioner Buesch had an idea of relocating the lights to the gangway, the lights would shine up rather than down from up above. The DNR requested more information from John Piccone (Sound West Engineering) about the renewal of the lease

Waterfront Improvement Project (Upland Improvements)

Commissioner Aho reported that all permits are behind schedule and we are still waiting for an answer from the county.

Pier Piling Repair;

BFP Grant application for piling replacement/other funding

Commissioner Aho informed the Commission about a phone call that John Piccone had with Henry at the RCO (Recreation and Conservation Office). Henry asked what the status of the Ports lease agreement with the DNR is? During that same conversation John asked Henry what the status of the BFP grant application was? Henry responded that the grant application will be processed soon.

Store Site Renovation:



Commissioner Buesch met with Dave Ghylin from Daves Septic Design and Dara with the Kitsap Public Health Department. Dave thinks he will be able to use the existing drain field site but has to wait for the Kitsap Public Health Departments approval to start his testing. Roy Barton asked if there are no problems with using the existing drain field site then you won't have to use the vacant lot for the drain- field, could you sell it? Commissioner Buesch Responded that Dave said to hang on to the lot just in case. When Commissioner Aho met with Dave last year he asked what would happen if someone wanted to use milk products or possible grease would you need to do anything different? Dave explained, that's when you need a separate holding tank, you do not want to put that material directly in to the drain-field. You would need to have a reserve drain-field. Commissioner Buesch responded that Dave discussed that possibility with him and that if the current drain- field or design is not acceptable, there is enough room north of the store to have a reserve drain-field. They would insert a snake with a camera on the end to determine if they need a reserve drain -field or not.

Commissioner Aho made a motion to approve Illahee Day's giving Commissioner Rupert a \$1,000.00 budget to work with (motion by Aho; second by Rupert all in favor).

Kitsap All Ports Association July 31, 2023 Meeting Minutes

The meeting was held in the Brownsville Yacht Club and via zoom. The meeting was called to order at 6:30 By Caleb Reese from the Port of Silverdale.

In attendance were Greg Englin, James Strode, Lary Coppola, Robyn Dally, James Weaver, Caleb Reese, Douglas Kitchens, Ed Scholfield, Steve Heacock, Tom Rose, Eugene Madayag, , Jennifer Olson, Joseph DaBell; From the WPPA: Eric Ffitch, Tasha Cilurso, Carly Michiels and Mandy Lill

In attendance on Zoom were Robert Ballard and Jeff Rupert

The Pledge of Allegiance initiated the meeting.

Introductions were provided for the attendees and for those on zoom.

After Introductions, Eric Ffitch with the WPPA (Washinton Public Ports Association) introduced himself to the group and gave bio on himself and his staff who was also there. Tasha Cilurso, Carly Michiels and Mandy Lill. Eric said the best way to help the Ports is to learn from other Ports and bring them together to share their experiences. He also mentioned he would invite the new CEO with PNWA (Pacific Northwest Waterways Association) to the small Port's convention, although they advocate for federal policies. While WPPA advocates for state policies and trying to work together for a common ground.

Port of Allyn

The Port of Allyn gave an update on the sealion invasion that destroyed a two-year-old dock, power peds, and pump out. They are having a difficult time getting contractors to bid on the project. They are also working with lobbyist to receive federal money to rebuild their dock.

Port of Manchester

The Port of Manchester got their cameras installed, they are also looking into redoing their resolution with the Kitsap County Sheriff's department. The Port recently called law enforcement about kids in the Port parking lot doing donuts and not abiding by the rules. The Sheriff's department cannot arrest them or enforce them to leave.

Port of Kingston

The Port of Kingston is 20% along with the design of their hotel project.

The County is going through the Comp Plan to increase height limit to 55 feet.

They are looking at all sources of funding from public sector, to private sector to present all options to the Commissioners. They also mentioned that the Port parking lot revenues is pretty close to pre-covid numbers.

Port of Bremerton

The Port of Bremerton reported that after two years NMIS has accepted their mitigation credits. They have more credits to buy, but they can move forward with the Port Orchard breakwater. The Port has support from the community with letters from the Sheriff, Fire District and the

Tribe. They inherited parking from the city of Port Orchard and need to update/rewrite the current ILA. Guest moorage with the Port is at 98 percent capacity. The Cruise ship is not a money maker but the Port is thinking it will boost tourism and be beneficial for the Port and the community.

Port of Poulsbo

The Port of Poulsbo reported that they are on the home stretch with their breakwater. Carol sat with the Suquamish tribe to work out the details. The tribe had a blessing ceremony at the Port of Poulsbo for the new breakwater. The Port also mentioned that they are short staffed.

Port of Silverdale

The Port of Silverdale reported that they chose American Construction Company for their dredging project. There is not electrical on the pier or floats they had an electrical fire/ shortage and the whole electrical system needs to be replaced because they cannot get an electrical permit unless it is up to code.

Port of Brownsville

The Port of Brownsville talked about their current derelict tug that refuses to pay moorage and Is putting the 28 people who have homes in the marina in jeopardy of losing their home. The Port also discussed setting up a derelict vessel group in the Kitsap Penisula so Ports can stay informed and we can help each other out.

The next Kitsap County All-Ports meeting date was identified as Monday, October 30, 2023, at 6:30 pm.


